It is clear that the trial court, in obtaining the information about the May 13 meeting, was merely following established procedure designed to protect the defendant's rights. Given the strong presumption of regularity surrounding criminal trials, it is not unreasonable to expect that the trial court will follow a rule of evidence and caution the jury that it may not be used as evidence of guilt. See also United States v. Baker, 855 F.2d 1353, 1359 (8th Cir.1988) ("we cannot say that the trial court's failure to warn the jury of the consequences of use of [evidence of unindicted offenses] in a limiting instruction was fundamentally unfair or an obvious violation of the Sixth Amendment"). Moreover, the court's response to the jury's question clearly did not constitute a second adversarial proceeding, but was in fact in line with the advice provided by the magistrate. An adversarial hearing is one instituted for the purpose of clarifying a point of law; a hearing held for the purpose of evaluating a jury instruction; or an adversarial proceeding is initiated "by the government itself when it is prosecuting a criminal case." Black's Law Dictionary 680 (6th ed. 1990) (emphasis added). The court's response to the jury's question did not constitute a second adversarial proceeding. In terms of the third factor, the court's response to the jury's question was not "prejudicial" in the sense of the term as used in Chapman. The jury's question was not directed to any "other crimes" evidence; rather, the question was narrowly confined to the use of the information which had previously been ruled admissible.
